I, the parent or guardian of _____, understand that:

A. I must pay \$_____ a week per child for each camp session I select under REGISTERED CAMP SESSIONS.

B. I must pay a \$100 non-refundable registration fee for each child that I register.

C. I must enroll my child for a minimum of **two** sessions (i.e., 2 weeks). If I withdraw my child before he or she completes the required two weeks, I must still pay for the required two weeks.

D. I must pay all camp fees on the Friday before the session begins.

E. I must pay the weekly tuition for all registered sessions when my child attends and when my child does not attend.
